

A. GENERAL

- The promotion is offered by Blueberry Markets ("Blueberry Markets"). Blueberry Markets is an authorised representative of ACY Capital Australia LLC, a company providing trading in financial and commodity-based derivative instruments and other securities and which is authorised and regulated by the St. Vincent and the Grenadines ("SVG"). This promotion is exclusive to selected clients (Selected Clients). Selected Clients are those who meet the additional Criteria listed below.
- The promotion shall commence on 1 December 2022 and is available until 31 December 2023 (Promotion Period). Any claims or requests made before the Promotion Period will not be eligible for participation unless specifically approved by Blueberry Markets.

B. CRITERIA

- 3. To be eligible for this promotion, Selected Clients must:
 - a. open a live trading account (**Account**) with Blueberry Markets;
 - b. not have made an Initial Deposit before the commencement of the Promotion Period, and

- c. May take up to 24 business hours to be added to the Selected Client's Account;
- d. Can be withdrawn as cash.
- 6. Real Equity on a Selected Client's Account is available for withdrawal at any point in time.
- 7. A Selected Client may choose to withdraw their Original Deposit at any time, provided their Original Deposit has not been lost in the course of their trading activity or is being used as margin.

Real Equity means the Net Equity of the account.

Refund Means the amount deposited by us into your account as
