

### A. GENERAL

- The promotion is offered by Blueberry Markets ("Blueberry Markets"). Blueberry Markets is an authorised representative of ACY Capital Australia LLC, a company providing trading in financial and commodity-based derivative instruments and other securities and which is authorised and regulated by the St. Vincent and the Grenadines ("SVG"). This promotion is exclusive to selected clients (Selected Clients). Selected Clients are those who meet the additional Criteria listed below.

# **G. DEFINITIONS**

**Original** means the amount of money initially deposited by you to participate in this Promotion and any further deposits made by you in accordance with clause 3 of these terms and conditions.

**Cash Bonus** means the amount deposited by us into your account which is equal to \$1000 and which can be used as a margin.

**Real Equity** means the Net Equity of the account, excluding any Cash Bonus.

**Net Equity** means the account balance including (after) any unrealised profit and/or unrealised loss on open positions. Net Equity is an

indication of the overall performance of an Account as it considers the Account balance and how each individual position is

performing.
