



A. GENERAL

1. The promotion is offered by Blueberry Markets ("Blueberry Markets"). **Blueberry Markets** is an authorised representative of ACY Capital Australia LLC, a company providing trading in financial and commodity-based derivative instruments and other securities and which is authorised and regulated by the St. Vincent and the Grenadines ("SVG").
